CCFRI

WWS' Little Cedars program has been accepted into B.C.'s [Child Care Fee Reduction Initiative \(CCFRI\)](#), as part of the 2019/20 Child Care Operating Funding Program. The CCFRI reduces the daily tuition rate by \$5 per day for children 3 years + and \$17 per day for children under 3 years of age up to \$350 per month per child.

Tuition Deposit

A tuition deposit of \$300 will be due March 1, 2021 to secure a space for 2021-22. This deposit will be directly applied to your May 5, 2021 tuition payment and is non-refundable.

NSF Charges

A charge of \$40 will be applied for pre-authorized debits that are returned to the School by your financial institution because of insufficient funds. The family must make immediate arrangement for replacement of refused payments. If acceptable arrangements are not made, the account will be considered in arrears and the student may be asked to withdraw.

Discounts

No discounts or fee reductions will be applied to our tuition fees for absences or sick days.

Change in days

To request a change in the days or number of days a student is enrolled, the Admissions Manager must receive a change request in writing one month before the change is requested to occur. The Admissions Manager may decline any enrolment change at their discretion and subject to space availability. All changes will be subject to a \$25.00 administrative fee.

Additional Fees

There may be additional fees required from time to time, such as fees for field trips, special projects, etc.

Tuition & Financial Obligations

PLAN A - FULL payment due by May 5, 2021 (Payments made by credit cards subject to a non-refundable 2% convenience fee)

PLAN B - TWO payments due by May 5, 2021 & October 5, 2021 (Payments made by credit cards subject to a non-refundable 2% convenience fee)

PLAN C - TWELVE payments due May 5, 2021 - April 5, 2022 and made via pre-authorized debit

Failure to make timely payments will result in termination of your childcare space.

Withdrawal & Tuition Refund Policy

It is essential that the School's annual income from tuition and fees be assured for it to honour its annual commitments to staff and other support partners. The withdrawal or dismissal of a student does not reduce overall operating expenses; therefore, parents are asked to make a financial commitment for the full year. If a student is withdrawn from the School for any reason (excluding major illness), the Admissions Manager must be notified in writing, and the notice must state the reason for the withdrawal and the final date the student will be attending the School. The following terms for the refund of pre-paid tuition and restrictions on the cancellation of unpaid fee obligations are defined below. Incidental fees including application, tuition deposit, school supply, & trip fees are non-refundable. No tuition refunds will be given after April 1 for that academic year.

Tuition refunds

The refund of tuition for students on financial payment Plan A (full payment) or Plan B (two payments) will be calculated from the month in which the student withdraws based on a May-April (12-month) payment cycle. Accounts will be reconciled as per the examples below.

- a. If a student withdraws in August four months' tuition will be retained and 8/12 refunded. Non-refundable fees remain non-refundable.
- b. If a student withdraws in October six month's tuition will be charged and 6/12 refunded. Non-refundable fees remain non-refundable.

No tuition refunds will be granted to students on financial payment Plan C (12 monthly payments).

- a. If a student withdraws in August four months' tuition will be retained and no further payments taken. Non-refundable fees remain non-refundable.
- b. If a student withdraws in October six months' tuition will be retained and no further payments taken. Non-refundable fees remain non-refundable.

If a student withdraws during the 12-week provisional period, tuition will be refunded at pro-rated amount based on number of months in attendance. Non-refundable fees remain non-refundable.

Completion of the Whistler Waldorf School Enrolment Agreement Notice of Appeal will be requested for withdrawals due to major illness. Requests must be supported by a written medical opinion from a physician in a form reasonably acceptable to the School in its sole discretion. Non-refundable fees remain non-refundable.
